#### 4. Reports

#### a. President's report

I am pleased to provide this report on the activity of Perinatal Society of Australia and New Zealand (PSANZ) for 2013. The mission of PSANZ is to foster communication and collaboration between all involved in the care of mothers and their babies to ensure optimal outcomes in the perinatal and newborn period and, therefore, longer-term health and wellbeing through high quality multidisciplinary research and clinical practice. PSANZ is a multidisciplinary organisation with membership including obstetricians, midwives, neonatologists, neonatal nurses, pathologists, epidemiologists, biomedical scientists, psychologists, parents (and other consumer advocates), physiotherapists, dieticians and other allied health professions.

### Membership

The membership continues to grow with 869 current financial members. In 2013, the membership categories were reviewed and revised to better reflect the membership of PSANZ. Current membership categories are Midwifery, Obstetrics, Neonatology, Neonatal Nursing, Basic Science, Epidemiology/Public Health, Allied Health, Consumer/Lay and Other.

### Implementation of the PSANZ Strategic Plan

The development of the PSANZ Strategic Plan in late 2012 heralded a time of change for PSANZ. The multidisciplinary nature of PSANZ is unique and critical to our continued success. In addition, strategies around supporting early career researchers, the conduct of clinical trials, engagement of parents, enhancing the conduct of the annual congress, increasing the profile of PSANZ, and more effective governance, were identified as priorities. Throughout 2013, members have worked with the board to implement the strategic plan through a number of activities and new initiatives including:

- PSANZ Policy Committee; to strengthen PSANZ's contribution to national policy, practice standards and guidelines relating to maternal and newborn care establishing PSANZ as a peak body on matters relating to perinatology
- PSANZ Consumer Advisory Panel; to provide advice to PSANZ on research and training issues from a consumer perspective.
- PSANZ Clinical Trials Network Working Party; to address how PSANZ can enhance the conduct of large scale clinical trials and epidemiological studies more effectively. This work is being undertaken by the Board with the IMPACT sub-committee and other partners in ANZ. The working party have engaged actively with the Australian Clinical Trials Alliance, a new initiative for promoting clinical trials across healthcare in Australia. The working party will make recommendations to the Board by mid-2014.
- PSANZ Conferences subcommittee; to oversee the effective conduct of annual conferences and PSANZ educational and promotional events

During 2014, the Board will continue to work closely with members through its Branches, Subcommittees, and Special Interest Groups to implement the strategic plan.

### Constitution

The strategic planning exercise identified the need for revisions to the current constitution and a new constitution will be put forward at the 2014 AGM.

- The *David Henderson-Smart Scholarship* acknowledges emerging leaders in evidenced based practice and continues as an annual tribute to this remarkable leader.
- The Early Research Career (ERC) committee travel grant awards are an ongoing initiative to encourage training and research in perinatology. The recipients of this grant will be announced during the Perth Congress.
- *New Investigator awards* have been an integral part of the PSANZ since its inception and provide an opportunity to showcase emerging talents in perinatal research. Congratulations to winners of these awards and we look forward to your continued contribution to perinatology as members of PSANZ.

**Special Initiatives (interest groups)** make an important contribution to PSANZ and it is hoped that, through implementation of the Strategic Plan, these entities will become a more integral part of the Society. Currently there are eight special initiatives. The IMPACT subcommittee continues to play an important role in facilitating and promoting the conduct of high quality perinatal clinical trials. In early 2014 a new special initiative group in Fetal Surgery was established; we encourage you to find out more about this new special initiative group and join if you share an interest.

### c. Notice to members of proposed changes to membership fees

The proposal to amend membership fees commencing January 2015 was discussed. The membership fees for PSANZ have not be been increased for some 8 years. The increased revenue of approximately \$12,000 will assist with the funding of the various new projects that PSANZ is undertaking now and those to be considered in the future to meet the objectives of the Strategic Plan 2013 as outlined above. Proposed amendments include:

AU\$150 for Australian corporate members. AU\$130 for Australian members earning > \$100,000 p.a. AU\$99 for Australian members earning \$50,000 to \$100,000 p.a. AU\$60 for Australian members earning < \$50,000 p.a. or full time students or consumers.

Need for transparency around corporate membership and compliance with the PSANZ Sponsorship Policy was discussed. It was asked which organisations were eligible to become corporate members and did this include industry. According to the new constitution, any organisation that, in the opinion of the Board, has a significant interest in perinatology or in advancing the objectives of PSANZ, is eligible to apply. Frank Bloomfield highlighted that the revised PSANZ Sponsorship Policy is very clear on PSANZ's position in terms of industry sponsorship.

The question arose as to why the proposed membership fees were to be means tested. This decision was made following much discussion around the need to attract to attendance of nurses, midwives and students who might have a lower income than others and who may not have other sources to cover membership fees. This system works well in New Zealand. It was acknowledged however that this could not be 'policed' and requires the honesty of members at the time of renewal.

Motion: The proposal to increase membership fees be accepted. Moved: Vicki Flenady. Seconded: Jon Hirst. Carried.

## 5. Appointment of office bearers to the Board

President-elect: Two nominations were received. Nominees Jonathan Morris and Greg Duncombe. Jonathan Morris was elected in an electronic ballot prior to this meeting.

Treasurer: One nomination received. Nominee Robert Guaran. Proposed by Lynn Sinclair. Seconded by Danny Challis. Elected unopposed.

## 6. Strategic Plan

The President presented an overview of 2013 PSANZ activity as outlined in the President's report of the annual report. In addition, the President's overview included details of how the Board are implementing the Strategic Plan including the introduction of a policy sub-committee, a conferences sub-committee and a consumer advisory panel. Frank Bloomfield (as co-chair of the PSANZ Clinical Trials Working Party) attended (with other PSANZ IMPACT representatives) the NHMRC supported Australian Clinical Trials Alliance (ACTA) summit in Melbourne. ACTA commended PSANZ on their work and for their development of the PSANZ Trials Database. The President encouraged all members to contribute to one of the PSANZ initiatives.

The President thanked Jane Pillow and her team for all their hard work in preparing for this congress and stated that the planning for future congresses had commenced.

### 9. Other business

Jon Hirst discussed the plan to introduce a PSANZ public lecture to be held on the Sunday afternoon prior to the congress beginning in Melbourne. It is hoped this will engage the community by addressing local and contemporary issues. It is intended to use a media, communications and marketing company to manage this process. The newly formed PSANZ consumer advisory panel could play a key role in this initiative.
