CONSTITUTION

The Perinatal Society of Australia and New Zealand operates according to a constitution and the rules which govern the Society.

INCORPORATION

The Perinatal Society of Australia and New Zealand Limted is an Australian Public Company, Limited by Guarantee. The company has an ACN, ABN and Tax File Number. In addition PSANZ has tax exempt status but is not entitled to receive tax deductible gifts.

The corporate key number is held by the President for the lodgement of documents to the Australian Securities and Investments Commission (ASIC). Any changes in Office Bearers need to be notified to the ASIC.

SECRETARIAT

PRESIDENT'S REPORT

PRESIDENT'S REPORT 2023 - 2024

On behalf of the Board of Directors, I am pleased to present the Annual Report for the Perinatal Society of Australia and New Zealand 2023-2024. It has been another busy year and productive year and I'd like to acknowledge the work from members across all disciplines within PSANZ, clinical and academic, including lived experience members. The PSANZ Society encompasses Discovery Science, Clinical Trials, Public Health, Epidemiology, Clinical Research, Health Systems Research and Policy with subcommittees and members comitted to driving new scientific discoveries, health care and clinical guidance around the world. I would like to thank our members: midwives, obstetricians, neonatologists, pediatricians, discovery scientists, epidemiologist's, policy makers and those with lived experience for ensuring PSANZ achieves our vision to improve health and long-term outcomes for mothers and babies. A key goal for PSANZ over last 12 months was to develop our new Strategic Plan, ensuring a focus on achieving equity in perinatal outcomes for Indigenous Australians and Māori people. To do this, the PSANZ Board working alongside Deanna Stuart-Butler, Liza Edmonds, Valerie Ah Chee, Janine Gliddon, Bev Lawson, Lisa Kremer and Jenny Rogers, commenced work on the new vision and Strategic Plan for the society moving forward.

The 2024 Congress provided the opportunity to meet in person to finalise the process and it was a productive and positive day. This past year, PSANZ also supported the inaugural Hui at Congress and I was presented with a wero signed by Indigenous attendees. This wero directed the PSANZ Board to establish an Elders Council and develop a Cultural Governance structure for the Society with the goal of embedding this Cultural Governance across all PSANZ activities. Another activity over the last year has been to re-establish and expand the consumer advisory group. Under the leadership of Natalie Merida, the subcommittee has grown and is now referred to as the 'Lived Experience Advisory Network(LEAN)'. The subcommittee is a unifying group for PSANZ consumers and includes external, consumer-led organisations that are interested in being involved in perinatal research. The Lived Experience Advisory Network are setting up a registry for those looking to be involved in PSANZ across workshops, and conferences, reviewing documentation and are creating a conduit for researchers and consumers to work together.







CONGRESS 2024

In April 2024, we held one of our largest and most successful Congresses in Christchurch/ Otautahi. The board is very thankful to Nicola Austin and the Local Organising Committee (LOC) for their hard work putting together the program and wonderful Congress. We had more than 900 delegates attend and the feedback was very positive. The board would also like to thank the sponsors of the congress and awards for their contributions to ensuring a successful congress. Planning for Brisbane 2025 in Brisbane is well underway with almost 500 abstracts submitted it is sure to be a vibrant and exciting meeting.

TREASURERS REPORT

The Society is now in a very solid financial position largely following a successful meeting in Christchurch this year –resulting in a reasonable final profit. Membership numbers have also grown substantially which has resulted in a significant increase in fees income (currently A&NZ 654 members) - associated with the increased attendance at the congress. Strong overall equity in the society as of Sept 24 of \$391,492. (with a congress budgets of close to 800k congress shortfalls could easily reduce our equity). Strong position going into Brisbane and our involvement with FAOPS at the 2026 meeting.

Of the total equity funds held for subcommittees represents \$139,135 (slightly less than last year as the subcommittees have been more active and used funds).
